County COVID-19 Community Equity Fund (CCCEF)

This is an effort designed to provide **funding** and **capacity building** to small grassroots and larger CBOs that are interested in providing COVID-19 relief and resources to the County's most under-resourced communities.

Public and Private Funding Investment

- **DHS** and **DPH** committed a **\$16.1M** investment in CCCEF for short-term projects lasting 1 year.
- 40-50 Organizations: \$100,000 to \$500,000 to deliver specific scopes of work.
- **Center for Strategic Partnerships and philanthropic partners** have committed funding to provide application assistance and may provide additional funding as needed.

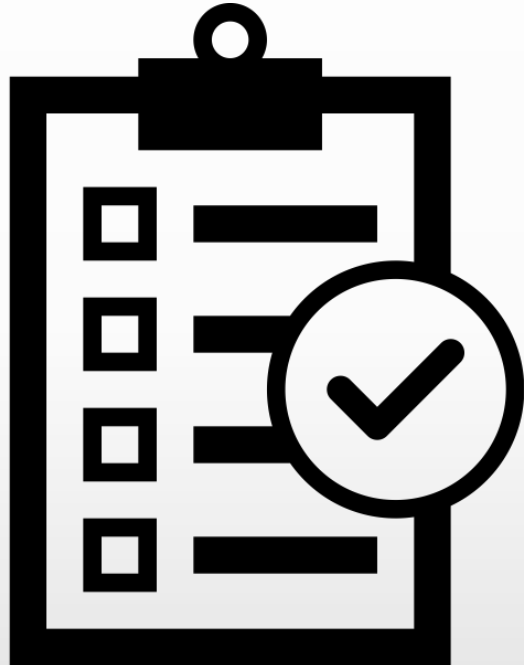
